Maryland State Firemen's Association Volunteer Company Assistance Fund Meeting May 19, 2013

The Maryland State Firemen's Association, Volunteer Company Assistance Fund meeting was hosted by the Hollywood Volunteer Fire Department at noon on Sunday, May 19, 2013.

Secretary Pat Bowser did such a good job of her minutes I decided to submit them with my report. We had two (2) cases at the May meeting.

Case #05-2013 - Antietam VFD in Washington County:

This case was a hold over from the previous meeting because of seeking legal advice. Antietam VFD was requesting a grant in the amount of \$162,134.24 to remodel an old existing building for a Firehouse. Their request was approved and forwarded to the MSFA Executive Committee.

Case # 06-2013 Benedict VFD:

Benedict VFD was requesting a grant in the amount of \$350,000.00 for remodeling their current Firehouse. Since we did not have that much grant money left, we gave them a grant in the amount of \$87,866.00 and forwarded their application to the MSFA Executive Committee.

A telephone conference call with the Executive Committee was called for and Antietam's request was tabled until the June 16^{th} meeting in Ocean City. Antietam's request was approved by a 9-3 vote by the Executive Committee.

Benedict was denied their request and I will let Dan Stevens, who is our Executive Committee Representative, explain their decision.

There was a meeting scheduled for July 28th but it was cancelled because there were no applications to act on.

The next meeting is tentatively scheduled for September 15th at noon at the Odenton VFD.

The meeting adjourned at 14:55 P.M.

The Volunteer Company Assistance Fund Board met on Sunday May 19, 2013 at the Hollywood Vol. Fire Department, Inc., St. Mary's County. In light of both the Chair and Vice-Chair's absence, Pat Bowser, Secretary presided. She asked everyone's patience today as she also took notes for the meeting.

The MSFA Representative present was: Executive Committee member Rodney Bowser.

The minutes from the previous meeting held at Joppa on April 5, 2013 were distributed to those members in attendance. The secretary noted that there were two attachments to the minutes which included discussion points when Treasurer Ron Siarnicki hosted a meeting at the National Fire Academy on March 8th and the presentation given by Craig Harman with the guidelines written in layman's terms.

Application # 2013—05 Antietam Fire Company, Washington County

Representatives of the company were present, and introduced were Robert E. Daveler, Treasurer; James Sprecher, Jr., Captain; and Ronald L. Horn, President. This was a second review for Antietam, as their application was tabled at the last meeting until a ruling could be made whether their application could move forward since they had a lease / purchase agreement with the City of Hagerstown for a term of 30 years, and if they own the property. The agreement was made two years prior. The company was requesting a grant in the amount of \$162,134.24 to complete their renovation project of their building. They reported the building, standing on the property when purchased, had underground storage tanks underneath. No one seemed to know why or how long the tanks were underneath. It was necessary to have the tanks removed and an environmental study and testing was to be completed before the renovation could continue. This additional step, which was not pre-planned took additional funds the company did not have. It was questioned if the previous owner, which was the City of Hagerstown, would be responsible for the removal and clean-up of the tanks. Captain Sprecher noted that the company took over the ownership and occupancy of the property and the city would not be liable as per their original agreement. It was noted that initially the City of Hagerstown did provide the company with \$200,000 to assist them with the renovation project.

It was noted that Michael Farlow, MSFA Attorney and Attorney General's Office Rep. David Porter have agreed that the lease / purchase agreement would lead to the eventual ownership of the property by the company and therefore, the application could move forward. It was also noted that a

justification would have to be submitted for a grant. The company reported they were financially strapped, and if a grant were not secured they may default on a loan.

They also reported trying to obtain a bond bill during the 2012 legislative session, however it died before moving out of committee. They tried again this past legislative session, and they did receive support of an \$85,000 bond bill.

It was also noted that their former Station was protected by the Historical Trust, so therefore

the building cannot be sold.

Pat noted their actual project cost totaled \$665,840.00; the company provided \$418,706.00 matching funds, with the \$85,000 from the bond bill and \$162,134.00 from a VCAF grant would complete their project. The company noted their agreement that the figures were complete.

After considerable questioning, Craig Harman recommended approval of their grant request to the Executive Committee. Joe Antoszewski seconded the motion. The motion passed by a voice vote

Pat noted that she would put together a letter, after approval by the Executive Committee to of the Board. both Catherine Kelly and David Porter, as this was a unique situation and the current pre-closing and closing documents outlined may be different and if so, the Attorney General's Office would have to write it to suit this particular situation. It was also agreed that the letter include a request for progress payments to be made, as the company did not wish to seek a bridge loan if at all possible.

She noted that she would make contact with Exec. Comm. Chairman Ben Kurtz and Richard Snader, data system's coordinator to set up a conference call within the next few days to seek their approval. She noted that afterward she would send the application to the Dept. of the Military for processing. She thanked Antietam for their patience in working through the process with the VCAF Board to assure the process was done correctly.

Application # 2013-06 Benedict Vol. Fire Department & Rescue Squad, Charles County

Brian Cusick, President; Frank Cusick; and Mark Garner, member and architect represented the

President Cusick began by stating that Benedict did not have any business's within their area department. with the exception of two restaurants. Their building was erected in 1950 with only two bays and hasn't had any type of renovation since it was built. The department had a need for renovation and due to the revitalization within the county, and the lack of any other available property to purchase, it was agreed the only way to move forward was to renovate their current building.

Their original loan was with their bank and the loan was for \$4 million for a period of 40 years. It was noted that in Charles County, there is a \$160,000 cap on loans from the county and the county didn't have any funding available. He said they were seeking a \$250,000 grant from the VCAF Board so they could continue and finish their renovation. The original contract bid cost was \$4.532,000, most of which was from a bank loan. He said that Charles County would not allow the department to enter into any more loan agreements, therefore they were precluded from seeking another loan, which they said they may not be able to repay.

After questioning, Joe Antoszewski moved to grant them the remainder of our grant funds for FY'14, which was \$87,866. John Gatton seconded the motion and the motion passed by voice vote. Pat asked the department if this was acceptable, since it wasn't the entire amount of their request. The

said it would be acceptable.

She noted that she would forward to them a pre-closing and closing outline, so they could indeed get their settlement documents together prior to the completion of their project. Pat also told the company they would receive a letter from her outlining the process after approval given by the Executive Committee sometime this week.

Pat made several remarks for the Board's information. She noted that Jason Baer would not be coming back in the new fiscal year and wondered what we could do from our board in appreciation for his many years of service and friendship to this board as well as the board of review. She knew it was at least 17 years of participation. It was agreed that each board member would sign the card passed around and each would contribute \$10.00 for a gift card of some kind.

Pat also made noted of attending Baltimore Pike's annual banquet, which hasn't been held in sometime. She said she was privileged to attend and represent the Board at their ground breaking ceremony for their addition to their building. She said she was most proud of them and noted how hard they have worked to rebuild their company. She noted that five of their retired members had returned to help put the company back on their feet and one remained as the company treasurer.

Craig reported the Catherine Kelly and he would be hosting a seminar on the VCAF Program at the convention. He said he thought it was to be on June 17th at 11:00 a.m. or there about. He said he'd let us know the exact date and time for any member to attend.

Our next meeting was discussed. After discussion, the meeting is tentatively scheduled for Sunday July 28, 2013, pending any applications. Craig Harman will be our host once again at Odenton, Anne Arundel County.

With nothing further to come before the Board, the meeting was adjourned at 14:55 hrs. .
