St. Florian 9-11 Lodge No. 238, AF & AM, the only Masonic Lodge in North America for Firefighters is proud to partner with the National Fallen Firefighters Foundation and the Prince Georges County Fire/EMS Department to host the first 9/11 Antique Fire Apparatus Muster, September 10, 2016.

The muster will be held in conjunction with the 2016 Prince George's County Fire/EMS Department's 9/11 Memorial Stair Climb & Walk at National Harbor, a census-designated place and development along the Potomac River in Oxon Hill, Prince George's County, Maryland just south of Washington, D.C. near the Woodrow Wilson Bridge.

The muster site will be the National Harbor Carousel Parking Lot (G) along the Potomac River. Due to previously scheduled events on the pier and limited access we will not be able to draft. Parking for haul/tow vehicles will be provided behind the Gaylord Hotel and free shuttle service provided between the muster site and parking area.

National Harbor is home to more than 150 diverse shops and boutiques and over 30 dining locations. Whether you're in for the day or staying at one of the awesome, convenient hotels, National Harbor's vibrant downtown atmosphere will delight you. National Harbor is directly accessible via the Woodrow Wilson Bridge, the Capital Beltway, I-95, I-495 and I-295—with interchange and multi-lane fly-off ramps exiting exclusively into the community from Maryland, Virginia and D.C. There are more than 150 hotels in the National Harbor area.

A MASONIC EVENT sponsored by the Grand Lodge of Maryland provides a Completed ID Package of identifying items generated at the event (NOT a blank KIT to be filled out at home). The packs contain vital identifying items to be given to law enforcement if their child is missing. MASONIC SAFETY ID EVENTS also serve as an opportunity to educate both children and their parents about Abduction Prevention and other safety information.

The proceeds from the muster benefit the National Fallen Firefighters Foundation and St. Florian 9-11 Lodge No. 238. Admission to the public is free. A box lunch courtesy of Mission Barbecue will be provided to registered Muster participants.
